
## HAPPY APRIL FOOLS DAY!

Ever wonder how trees are cleared from trails in the Wilderness? The USFS is responsible for clearing Wilderness trails and does an incredible job with the resources they have. However, due to the amount of deadfall in Eagle and Summit County, they need the additional help of volunteer organizations like ESWA.

In 2022, ESWA adopted 16 trails in Eagle and Summit Counties and cleared over 1,000 trees from those trails. Clearing fallen trees helps avoid trail braiding and erosion. For 2023, we plan to do even more, and we need your help! Our Sawyer

#### ESWA'S PARTNERSHIP WITH NFF GOING STRONG!



The National Forest Foundation (NFF), through its Ski Conservation Fund, has been a major supporter of our WeedSpotter Program and Llama trips for the last four years. This past month we were pleased to hear that ESWA has been awarded a grant to continue this important work in 2023. The funds for this project come from the NFF, as well as A-Basin, Copper Mountain, and Vail Resorts. We thank them!

We also thank all the ESWA volunteers. You may not realize it, but the NFF grants (like most other grants) require ESWA to provide matching funds, or in-kind contributions. Because we have such a strong volunteer base - WeedSpotters, VWRs, THHs, Sawyers, Trail workers - we are able to cover all our matching requirements with volunteer time. So, any time you spend an hour working in the Wilderness, you're also creating \$25-30 of in-kind

contributions. This is a great way to amplify our funding - keep up the good work!

Speaking of amplification, the NFF recently featured ESWA on their social media. During the last week of March, ESWA posts on Facebook and Instagram were tagged with NFF hashtags. The NFF relayed this to their 430,000 followers - giving ESWA huge exposure nationwide!

#### ADVENTURES TO NURTURE THE WILDERNESS

Join ESWA and the USFS on ESWA's backpacking overnight llama trips or day work trips this summer. Whether an experienced backpacker or a first-timer who would like to backpack with some friends, you are welcome to experience the Wilderness and help maintain its pristine beauty on ESWA's weekend trips into the backcountry. Or perhaps you would prefer a day trip to learn trail building and help construct a new trail above Cataract Lake, or learn to identify and pull those pesky noxious weeds that are trying to overrun our Wilderness. - July 7-9: Eagles Nest Wilderness: Soda Lakes (north of Piney Lake)
- July 21-23: Eagles Nest Wilderness: Wheeler Lakes and Lost Lake (Copper Mtn Exit)
- August 4-6: Eagles Nest Wilderness: Gore Lake
- August 18-20: Eagles Nest Wilderness: Willow Lakes (above Silverthorne)
- August 24-27 (3 nights!): Flat Tops Wilderness (northwest of Gypsum)

Day Projects (more to be added as season progresses):

- July 15 & July 16 Eagles Nest Wilderness: Surprise Lake Day Trip to help build a new trail. No experience required and we all work at our own pace. It is less than a 2-mile hike in with a thousand-foot vertical gain. Sign up for one day or both. Contact

- July 8 & July 18 ESWA is very active in fighting the pernicious invasive weeds that try to infest our Wilderness. Like a biological wildfire, they crowd out the native vegetation --the food our native animals need. Some of these invaders must be sprayed, but others can be pulled. This year ESWA is working with FDRD (Friends of the Dillon Ranger District) on two weed pulls. The County Wide weed pull for Summit County is on July 8 and a follow-up weed pull is at Hunter's Knob on July 18. ## **VWR TRAINEES AND VWR MENTORS NEEDED!**

Replenishing the ranks of our VWRs is essential every year.
