

From President Currie Craven

Happy Holidays to you wonderful folks, FENW! Thanks for making 2009 a very successful year for public lands stewardship and partnerships that FENW has enjoyed over the last twelve months. I'd like to take a brief part of this newsletter to update you on some of the issues your FENW Board of Directors has been involved in this year.

Travel Management: As part of the White River National Forest (WRNF) land and Resource Management Plan revision, the Travel Management process is well underway. The USFS has announced a preferred alternative, referred to as "Alternative G". After much analysis and sorting through public comments, the USFS selected this alternative and describes their selection this way. "This alternative strives to balance the public transportation needs, including recreation uses, with natural resource protection and enhancement. The alternative was designed to best meet the public desire to access and recreate on the national forest in a natural setting". The WRNF is preparing the Final Environmental Impact Statement for release in January or February. Another opportunity for public comment or legal challenge will then be opened. Wilderness will be impacted primarily through decisions made regarding social (non-system) access to Wilderness. FENW will keep you updated. • Hidden Gems Wilderness Campaign: Many of you have heard of this citizen led initiative to add designated Wilderness acreage to the WRNF. Currently, approximately 6% of Colorado is in this highest level of land protection and this proposal would add only .5% more. The



proposal would add only .5% more. The campaign has been very diligent in seeking input from all stakeholders regarding identifiable boundaries and relevant issues for consideration. Locally, the Gems proponents are still involved with the County, Towns, and other user groups to determine (hopefully) broad consensus to move the proposal forward. FENW has expressed support for the <u>process</u>, and is in touch with proponents and stakeholders to find if consensus may exist. For more information, please see www.whiteriverwild.org.

Tools & Equipment Program Status

<u>Report.</u> George Resseguie Note: Membership dues have helped greatly in the purchase of these tools which are used for trail improvement work.



For 2009, the FENW continued to provide high quality tools and equipment to Summit County non-profits, and the tools were used on projects that generated about \$140,000 in volunteer labor. Besides the 4 FENW trail maintenance projects (see details elsewhere in the newsletter), the key user of the tools was the Friends of the Dillon Ranger District (FDRD) which coordinated 1500 volunteer days (7,600 volunteer hours), including trail construction and maintenance, structure installation, and turnpike construction. Included were Adopt-A-Trail projects with the following key FDRD partners/users of the tools & equipment: Town of Frisco, Greenlands Reserve Land Trust, Summit County Seniors, Christy Sports, Copper Mountain Resorts, and the Summit County Off-Road Riders.

We would like to extend special thanks to Len Shipman for designing and building storage racks for the McLeods, Pulaskis, Pick and Cutter Mattocks, shovels, and other large tools in the Tool Shed which freed up significant space for other storage and for general moving around. We also would like to thank Tom Brennom, Doty Davies, and Guff Van Vooren for cleaning, oiling, and sharpening the tool inventory, and Ken Waugh at the USFS for "donating" usage of the Outhouse Building, so named because of its unique shape, for additional storage.

FENW again with the support of the National Forest Foundation grant of \$10,000 had Weed Busters and John Pickering with his mules on hand for 8 days of spot spraying at 11 locations in the Eagles Nest Wilderness and National Forest land approaches on both the Summit and Eagle side. We are making progress but must be vigilant going forward.


Our volunteer weed survey crew and backpack sprayer contingent made a difference by taking on the small patches using 63 gallons and 80






