SEASON UPDATES

ESWA's volunteers have been busy this summer! ESWA VWRs organized four weekend-long work trips, assisted by our friendly llamas Dom and Monty and our USFS Ranger colleagues. At Nolan Lake, Lake Charles, Upper Cataract, and Slate Lakes, we removed over 100 illegal fire pits, erected no-campfire signs, and collected and carried out untold amounts of trash.



And here are some impressive patrol and trailhead hosting numbers, as of August 28 (stay tuned for our amazing Sawyer stats in next month's newsletter):

PATROLS:

- 103 VWRs conducted 337 patrols over 1,618 hours
- 8,145 users contacted, including 696 overnight users
- 160 fire-safety conversation held
- 76% of dogs encountered were on leash
- Ellie Finlay did the most patrols (17) and logged the most hours (91.5)

TRAILHEAD HOSTS

- 28 VWRs hosted at 16 trailheads over 97 hours
- 1,112 users were contacted, including 27 overnight users
- 18 fire-safety conversations held
- 94% of dogs encountered were on leash
- Joan Betz did the most trailhead hosting shifts (5) over the most hours (19)

ESWA AND USFS ERECT EDUCATIONAL SIGNS AT HOLY CROSS AND EAGLES NEST TRAILHEADS

ESWA funded and helped the USFS design a series of three educational signs to be erected prior to the Wilderness boundary on several of our most popular trails. These include a Leave No Trace sign, a sign with rules and guidance on taking your dog into Wilderness, and one on general Wilderness values and regulations. For the trails that received signs last year, our VWRs report increased compliance with the Wilderness regulations, including keeping pups on leash!

ADVOCACY UPDATES



ESWA continues to advocate for a number of campaigns to protect our three local Wilderness Areas. These include:

Protecting winter habitat for bighorn sheep. ESWA supports the Town of Vail's efforts to protect the last-remaining bighorn winter habitat in the valley. Check out ESWA's latest [Get Wild article](#) in the Summit Daily on our amazing state animal.

Passing the CORE Act. The Colorado Outdoor Recreation and Economy Act, CORE, has passed the House four times, but has yet to make it through the Senate due to Republican opposition. ESWA and many conservation groups have worked for years to obtain CORE passage, which would provide Wilderness Act protection to 73,000 acres, including additions to the Holy Cross, Eagles Nest, and Ptarmigan Wilderness Areas. Senators Bennet and Hickenlooper, Congressman Neguse, and Governor Polis recently announced a new plan to urge President Biden to give these areas protection as a new national monument, called the Camp Hale-Continental Divide National Monument – this [Colorado Sun article](#) has more info. The new national monument would encompass not only Camp Hale, but also nearby areas where the 10th Mountain Division trained, which could include areas that CORE would make Wilderness. ESWA is closely monitoring this important new proposal, and we are pushing hard to include the most protection possible for the proposed Wilderness Areas (and for future passage of CORE). We will keep you posted about developments and getting involved!
